Offering a unique opportunity children to begin and continue their grief journey, New Hope for Kids strives to provide our families with hope, healing and renewal. We also extend support for the entire family through parent support groups, community awareness projects, information and referral services, as well as family events and a summer camp throughout the year. Thanksgiving meals were provided to the Center's families and holiday gifts were given to over 200 children. In 2010, 212 families were served (327 children and 245 adults).
